***THE CORNHOLE TOURNAMENT TAKES PLACE IN THE HOSPITALITY TENT;
NO ONE UNDER 21 YEARS OF AGE IS ALLOWED TO PARTICIPATE. ID REQUIRED FOR ADMISSION.***

RULES: No displays of public misconduct or vulgar language will be permitted. Refunds will not be granted to those disqualified from participation. Games are played to 21 points. This single elimination tournament is doubles play; all teams must have two players. Scoring consists of three points for a bag that is pitched and goes through the hole at any time during the frame and one point for a bag that has been pitched and remains on the cornhole board playing surface at the conclusion of the frame. If a bag comes to rest on the board and the ground, it does not count as a point. Cancellation Scoring: during each turn (half a frame), the points of one player cancel out the points of their opponent. So, if player A scores two 3-pointers and one 1-pointer and player B scores one 3-pointer and two 1-pointers, Team A scores three points and team B scores one point. Teams are responsible for keeping track of their score together and reporting it to the official scorekeeper and judge.
